Warranty and Regulations

Limited Warranty

The IFH Group warrants all containers, racking (except special order racking), PVC hose, flex-steel hose, and drip pan and screen component parts of the oil storage and dispensing system to be free from defects in material and workmanship under use and service in accordance with installation instructions, for a period of FIVE YEARS from date of installation by the original purchaser.

The IFH Group warrants all electrical motors in the oil storage and dispensing system to be free from defects in material and workmanship when operated under normal conditions in accordance with nameplate characteristic limits for a period of ONE YEAR from date of installation by the original purchaser.

All other component parts, pumps, accessories, and optional equipment, including special order racking, is warranted to be free from defects in material and workmanship under use and service in accordance with instructions for a period of NINETY DAYS from date of installation by original purchaser.

The IFH Group's obligation under this warranty shall be limited to the repair or exchange of any part or parts which may prove defective under normal service within the time limitations set forth above, and which our examination shall disclose to our satisfaction to be defective. THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND ALL OTHER OBLIGATIONS OR LIABILITIES ON OUR PART.

This limited warranty does not cover any defects, malfunction or failure caused by or resulting from improper or unauthorized service, maintenance, installation, repair, or use not within installation instructions or specifications, or from abuse, neglect, accident, or any other cause beyond the control of The IFH Group. This limited warranty is made only to the original purchaser, which shall be deemed to mean that person for whom the oil storage and dispensing system is originally installed.

This warranty shall apply only within the boundaries of the Continental United States. The IFH Group neither assumes, nor authorizes any other person to assume for it, any other liability in connection with the sale of the oil storage and dispensing system.

The IFH Group shall not be liable for any incidental or consequential damages, and liability hereunder is expressly limited to repair or replacement of any part or parts which may prove defective within the time prescribed herein.

Product Boundaries

IFH Storage and Dispensing Systems are designed for storage of lubricating oils and products with a Flash Point above 150°F. STORAGE OF PRODUCTS WITH A FLASH POINT LESS THAN 150°F IS STRICTLY PROHIBITED.

Material Safety Data Sheets are mandatory and are to be mailed or faxed to us for review for storage of any product, other than lubricating oils, for our approval.

The IFH Systems are the answer to many types of storage and dispensing applications. The IFH System is safe, efficient and promotes good housekeeping but must not be used for storage of unapproved products such as those with a Flash Point of less than 150°F.

6. I understand that (i) except as expressly stated above, no other warranties are applicable, and no other damages will be recoverable from IFH or Lubrigard.
