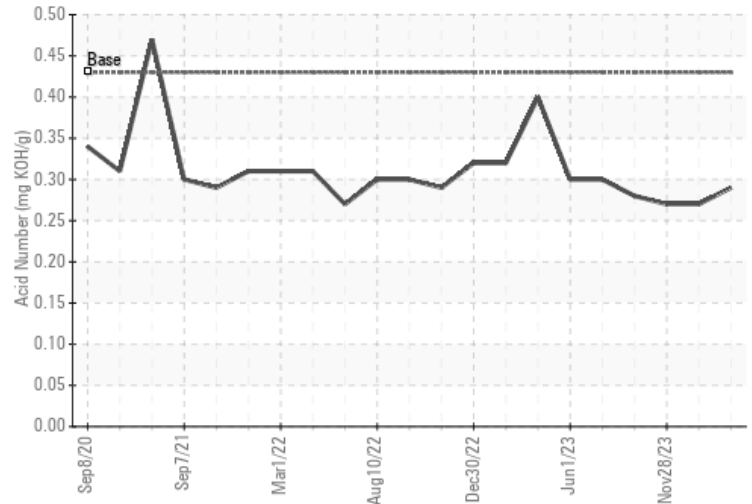
Non-ferrous Metals
