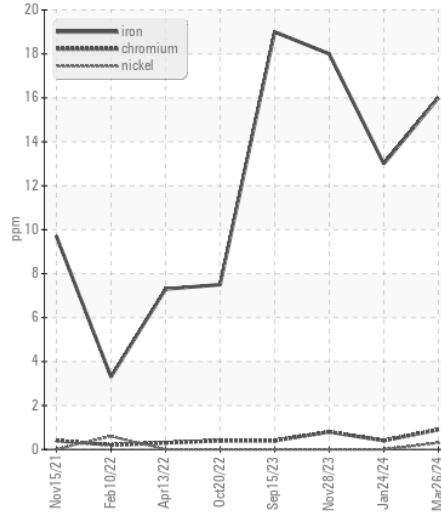

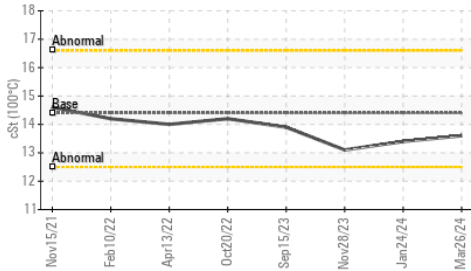

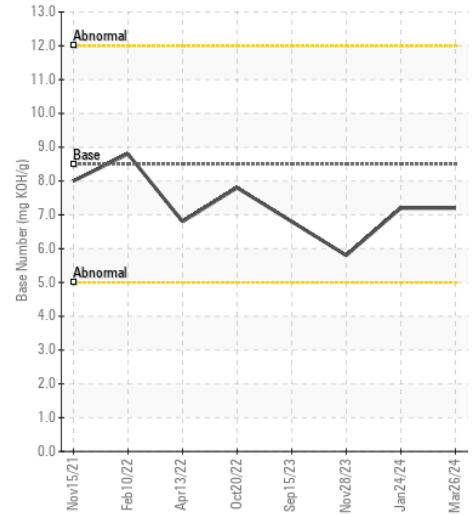
**Non-ferrous Metals**
