All component wear rates are normal.

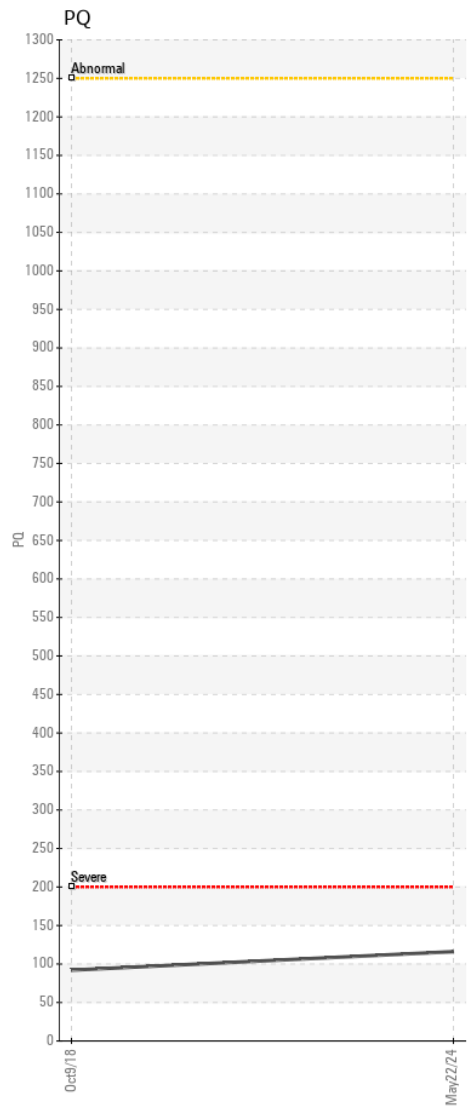
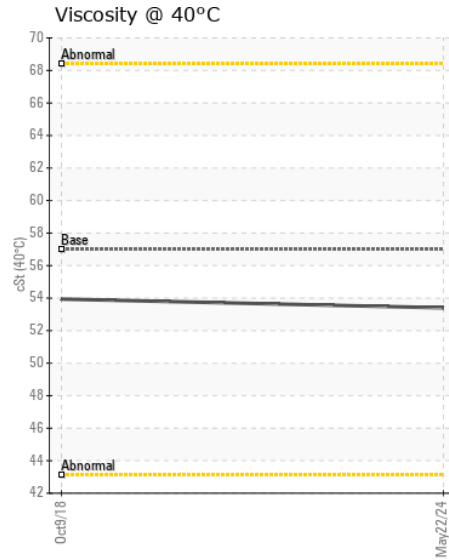
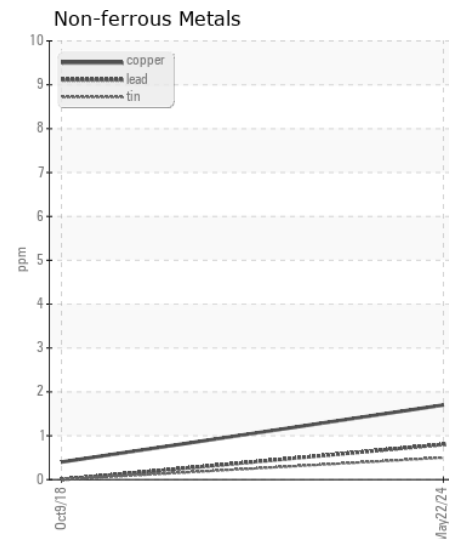
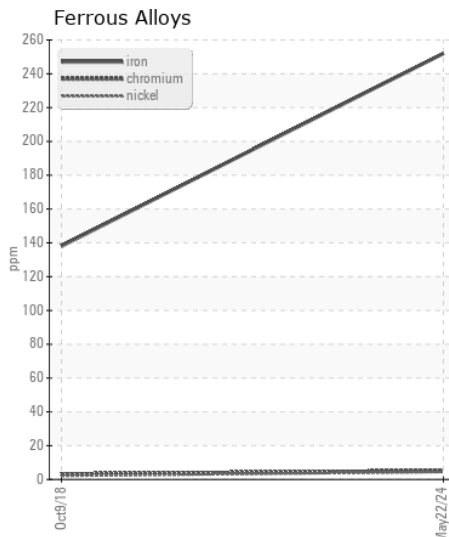
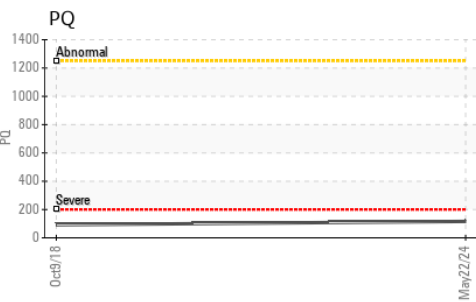
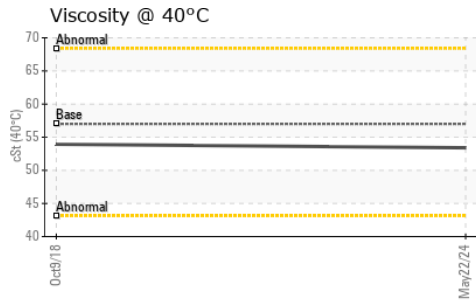
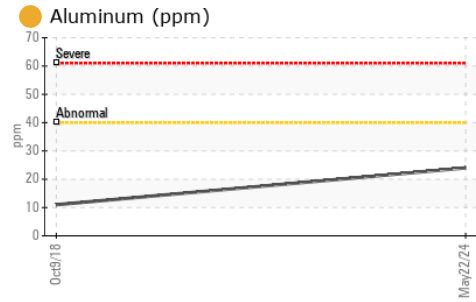
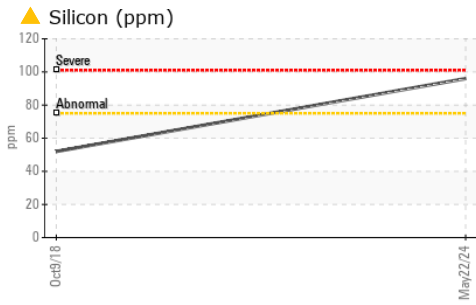
### CONTAMINATION
