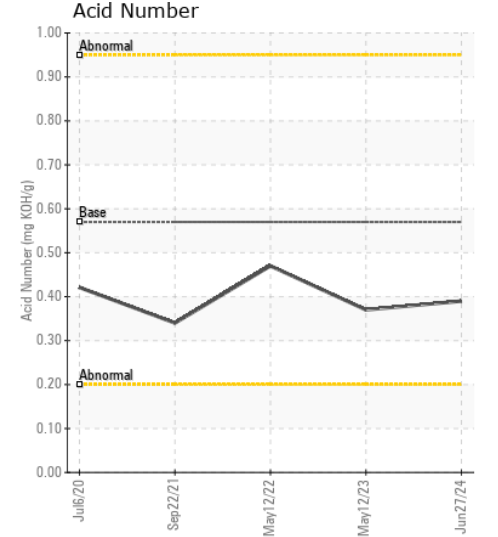
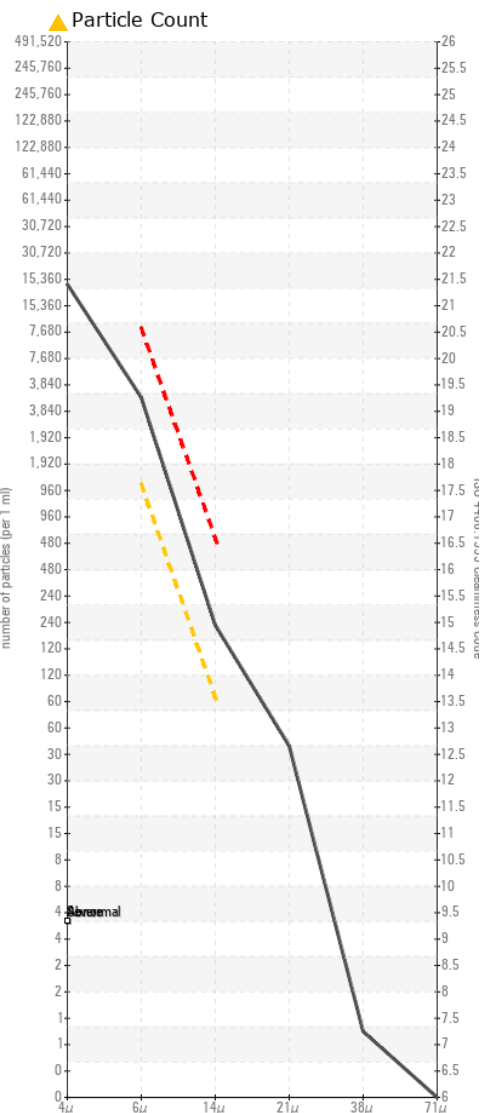
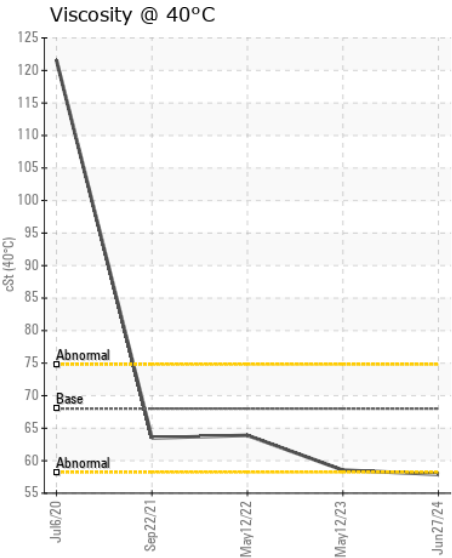
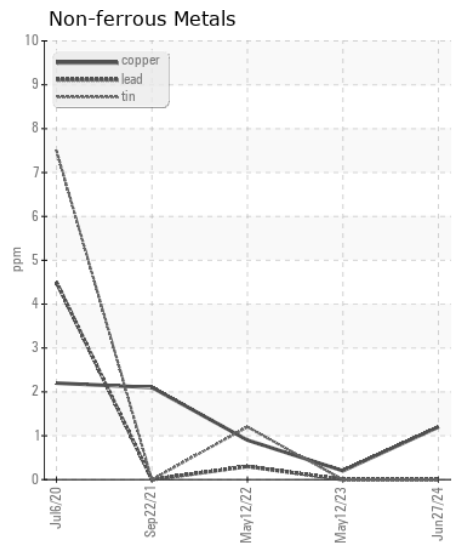
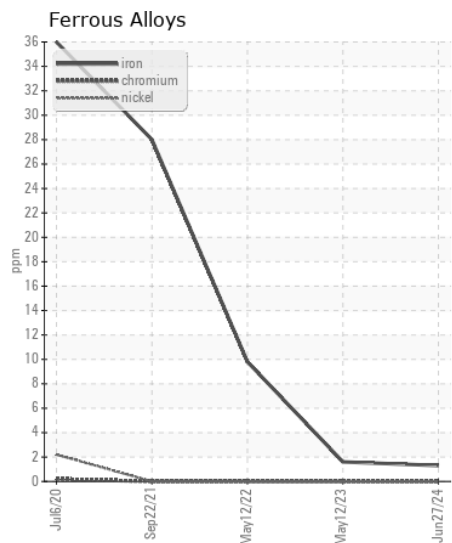
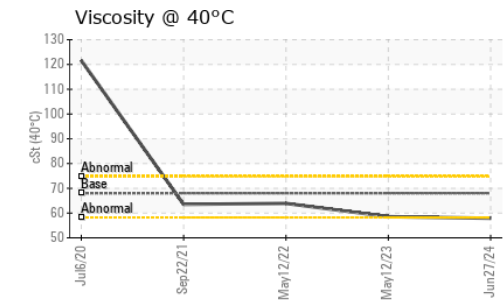
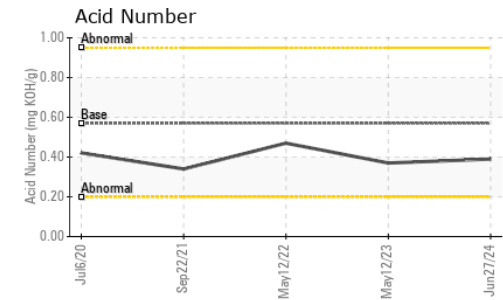
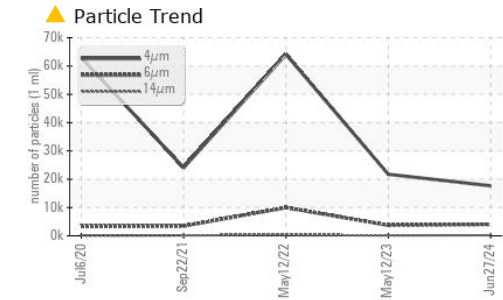
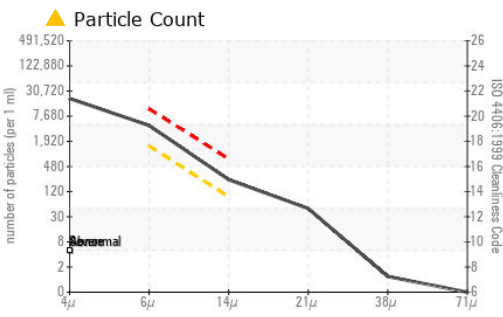
CONTAMINATION
