### DIAGNOSIS

#### Recommendation

We recommend drain system, and refill with 50/50 antifreeze water mixture. We advise that you replenish the supplemental coolant additives (SCAs) and add per manufacturer's specifications. Resample at the next service interval to monitor.

#### Corrosion

All metal levels are normal indicating no corrosion in the cooling system.

#### Contaminants

There is no indication of any contamination in the coolant.

#### Coolant Condition

The reserve alkalinity of this fluid is lower than acceptable. The coolant is cloudy indicating either an overconcentration of coolant additives, or a mixing of incompatible coolant technologies. The low nitrite level indicates reduced cavitation protection which leads to corrosion and ammonia formation. The pH level of this fluid is within the acceptable limits.


