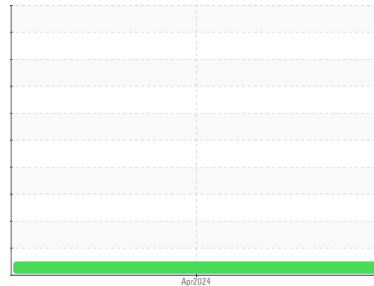

Fuel Condition



The condition of the fuel appears acceptable for service.

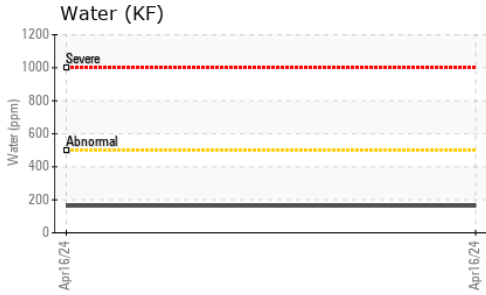
