Particles >4µm and oil cleanliness are notably high.

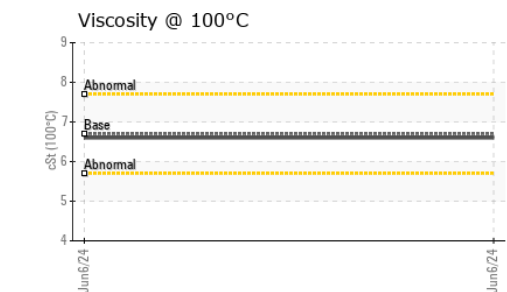
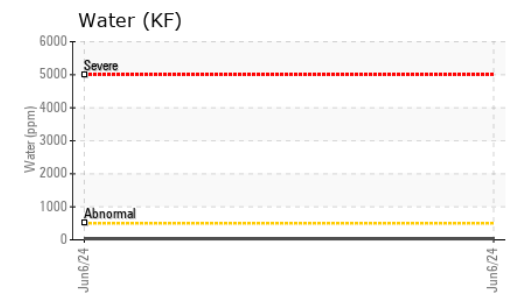
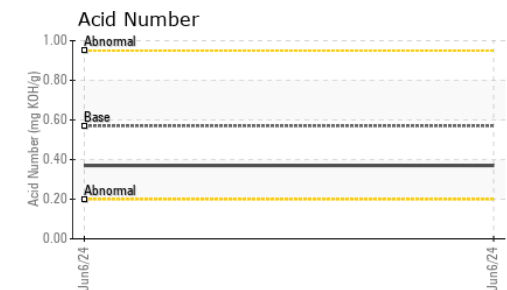
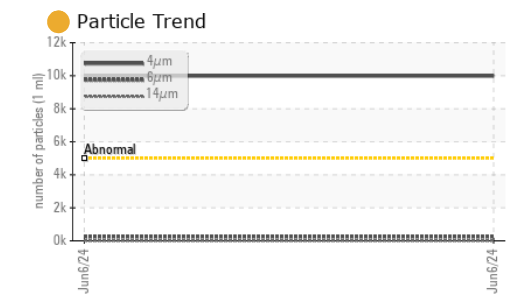
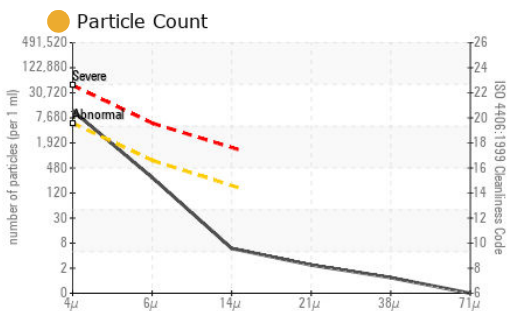
