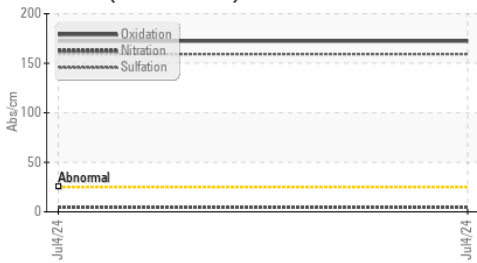

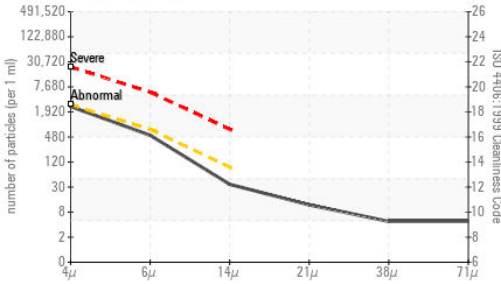

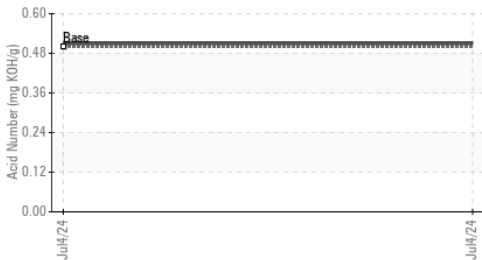
FT-IR (Direct Trend)



Particle Count



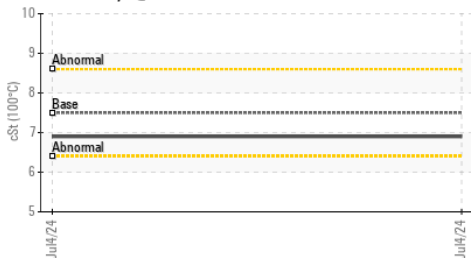

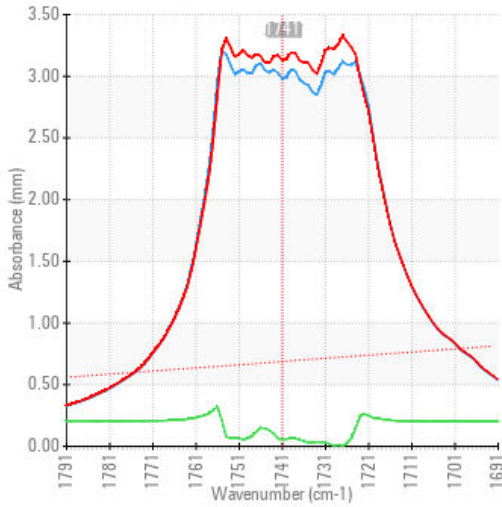

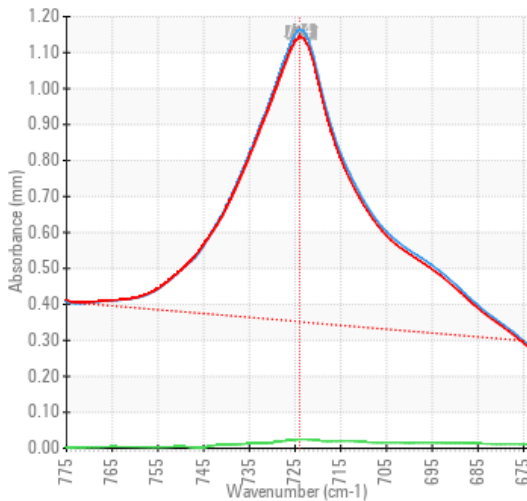

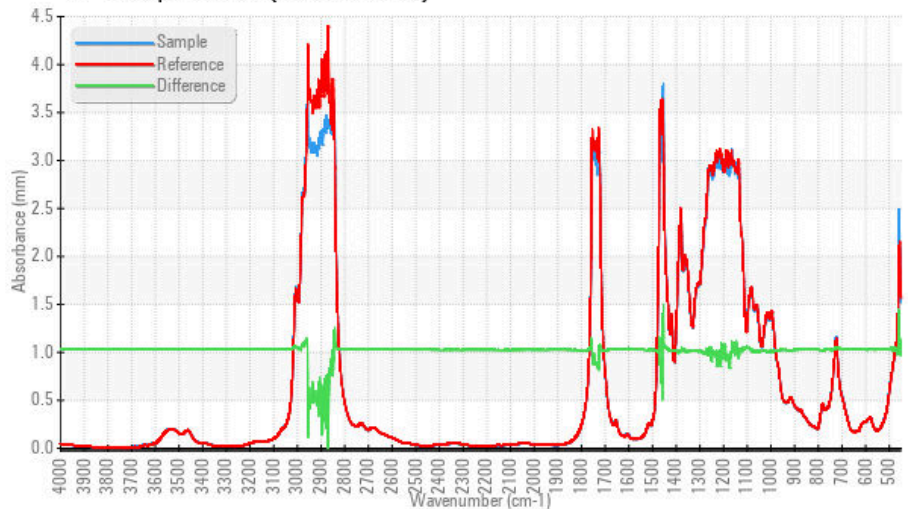
### FT-IR - Esters I
