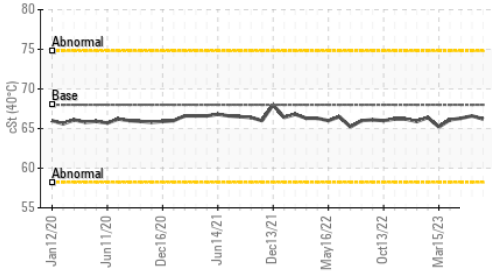
Particle Trend



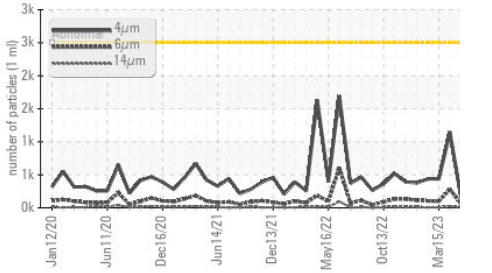

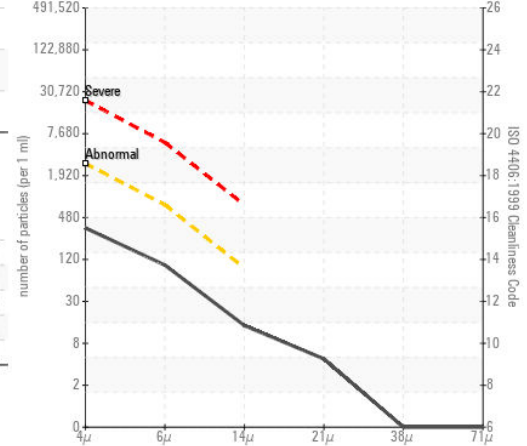

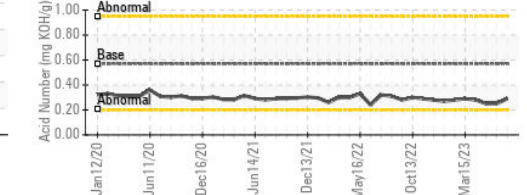
