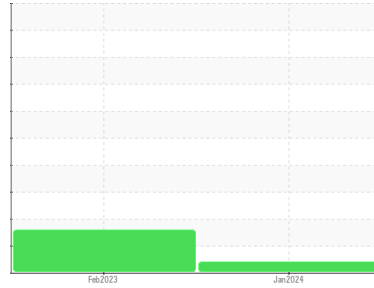

▲ Recommendation

Moderate concentration of visible dirt/debris present in the oil.
