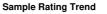

There is a moderate amount of particulates present in the oil.

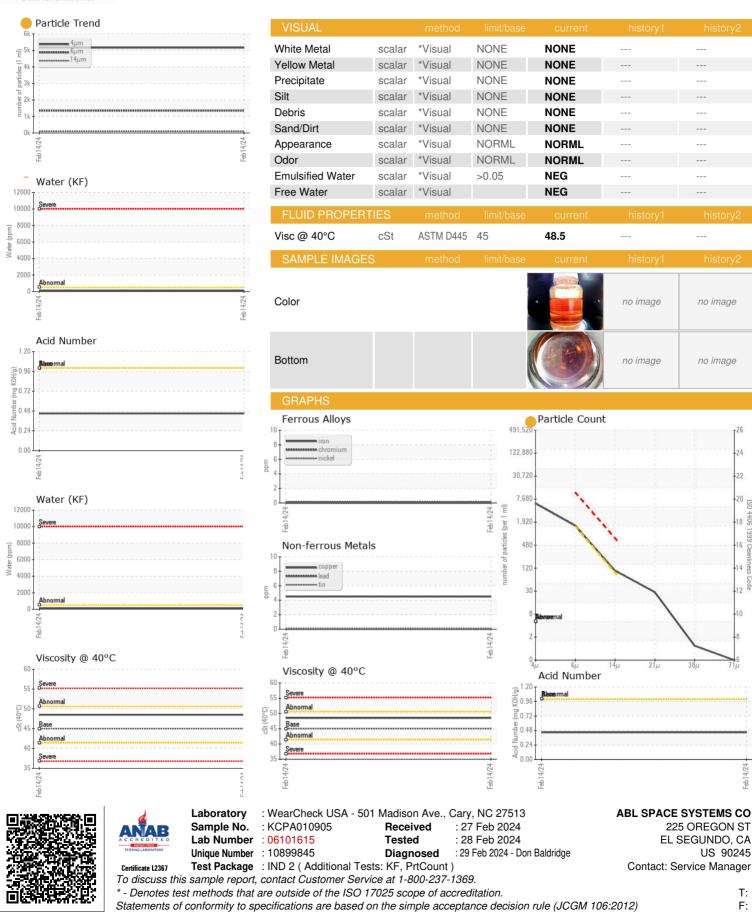
