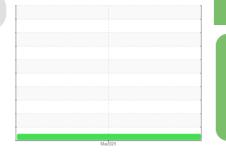

Sample Rating Trend

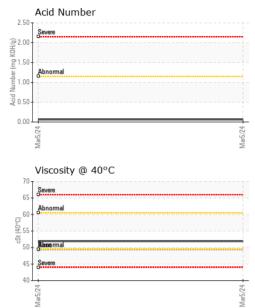
