Wear


All metal levels are normal indicating no corrosion in the cooling system.

Contamination

NAS 1638 Class: 12, Discrete particle counts [100 ml] $5-15\mu$ m = 317100, $15-25\mu$ m = 54000, $25-50\mu$ m = 18200, $50-100\mu$ m = 2800, $>100\mu$ m = 300. There is a high amount of particulates present in the fluid. The system cleanliness is above the acceptable limit for the target cleanliness code.

Fluid Condition

The glycol level is acceptable. The pH level of this fluid is within the acceptable limits.
