The AN level is acceptable for this fluid.

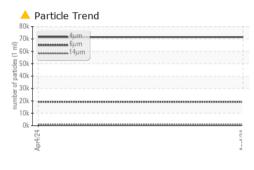

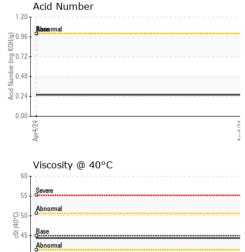

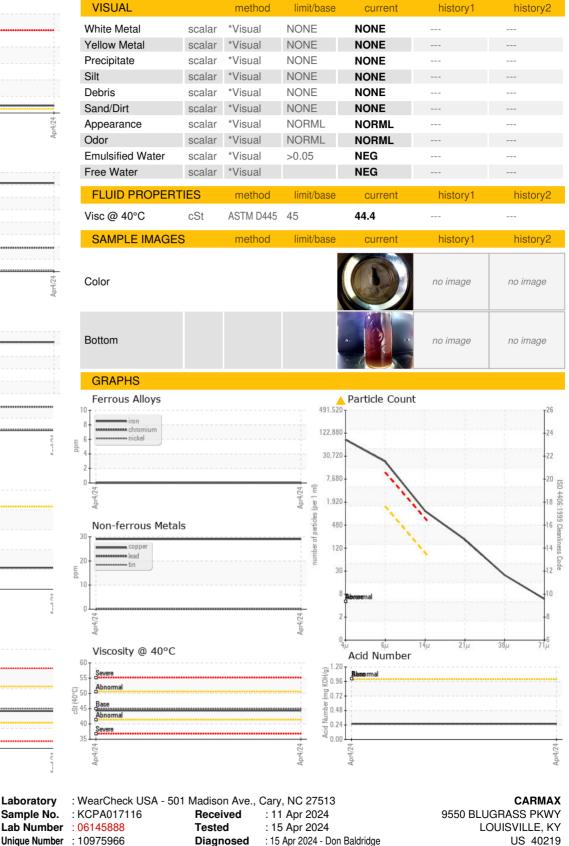
