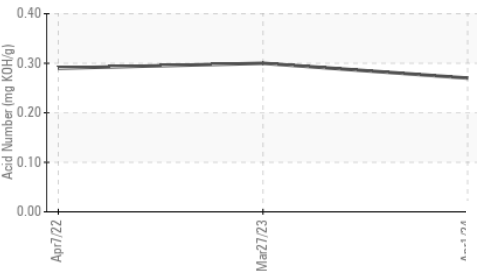
▲ Particle Trend



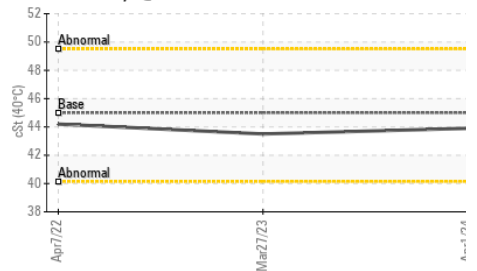
