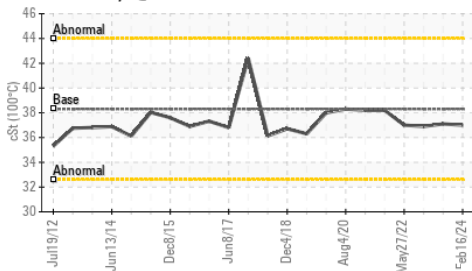
Viscosity @ 100°C



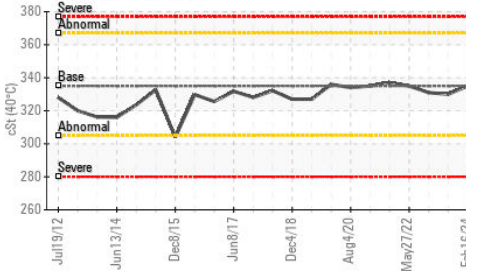
Particle Trend



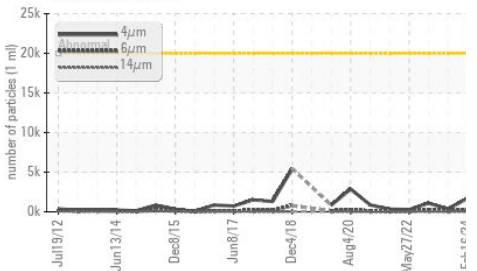
Viscosity @ 100°C

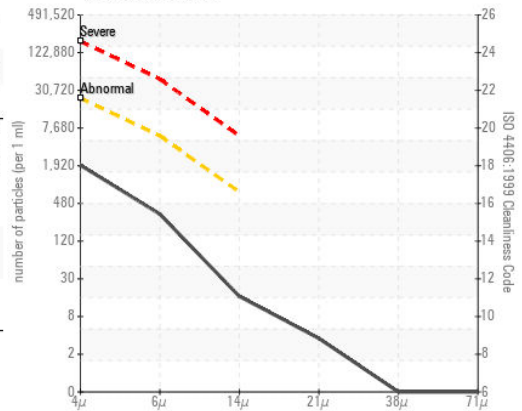

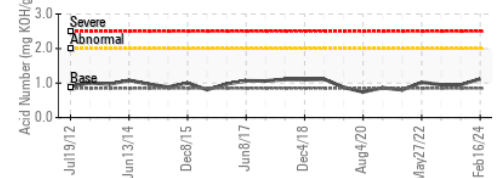
Viscosity @ 40°C
