The water content is negligible. There is no bacteria or fungus (yeast and/or mold) indicated in the sample. There is no indication of any contamination in the fuel.



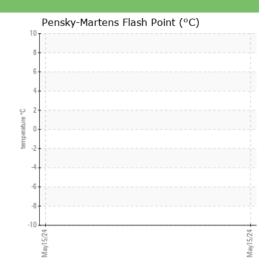
