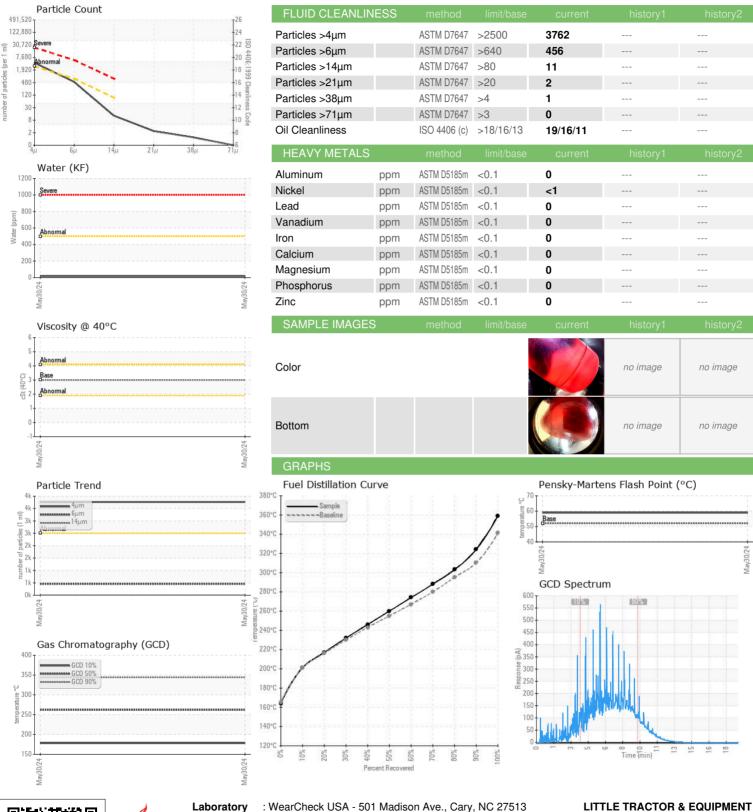
Fuel Condition
