## DIAGNOSIS

### Recommendation

We advise that you perform a filter service and use off-line filtration to improve the cleanliness of the system fluid. Resample at the next service interval to monitor. There is too much water present in this sample to perform a particle count.

#### Wear

All component wear rates are normal.

#### Contamination

Appearance is milky. There is a high concentration of water present in the oil. The high sodium (Na) level indicates the possible presence of salt water.

## Fluid Condition

The AN level is acceptable for this fluid.
