

#### Recommendation

Resample at the next service interval to monitor. We were unable to perform a particle count due to a high concentration of particles present in this sample.

#### Wear

All component wear rates are normal.

### Contamination

Moderate concentration of visible dirt/debris present in the oil.


#### **Fluid Condition**





