The water content is negligible. There is no indication of any contamination in the oil.

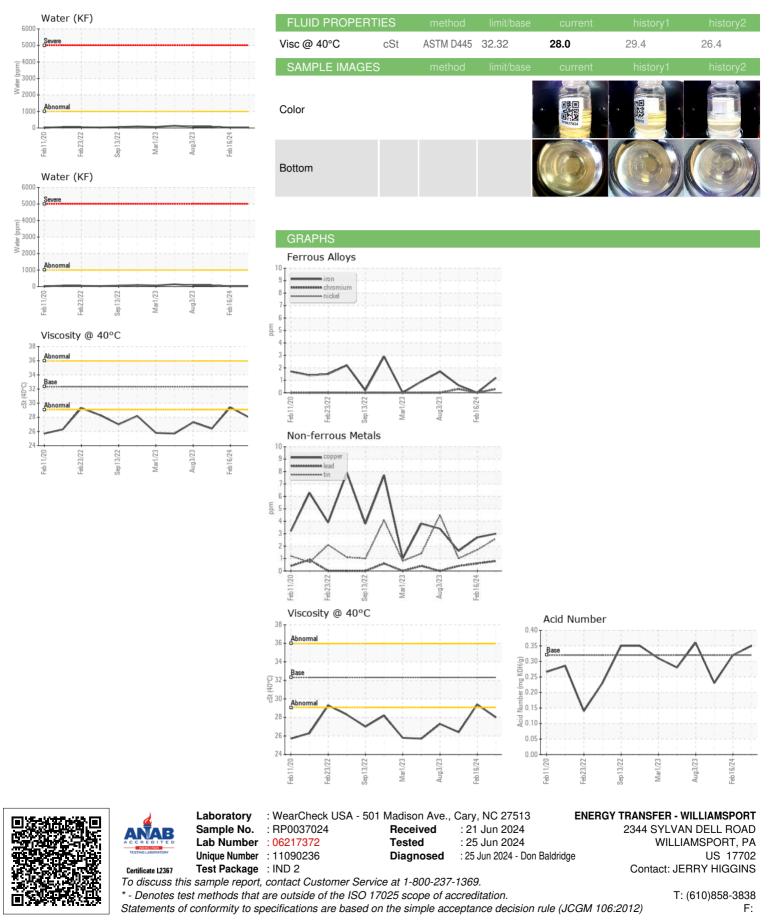
